



## GLL/GJBA Game & Practice Cancellation Policies Due to Weather and/or Field Conditions

Head Coaches and Parents shall assume that games/practices ARE ALWAYS ON unless specifically notified otherwise. Parents shall not contact the Field Owner with cancellation questions. Parents shall not contact Head Coaches prior to 3:00 PM with cancellation questions. A central cancelation phone number and/or website does not exist for GLL/GJBA. Weather conditions can vary widely across different parts of Jefferson County.

<p><b>Note(s):</b>  <b>G1</b> = Field Owner retains sole authority. If the Field Owner decides to cancel access due to weather and/or field conditions, the Field Owner will contact the GLL/GJBA administration. Then, the GLL/GJBA scheduler/re-scheduler will immediately notify (1) the Assigned Head Coach's cell phone via voice and/or text message and (2) change the game status in the scheduling software (TeamSideline). The Head Coach shall then immediately notify Parents' cell phones via voice and/or text message. The Head Coach shall not completely rely upon emails to notify Parents. Coaches and Parents shall not completely rely upon automated notifications sent via the scheduling software (TeamSideline), as that method of communication is notoriously unreliable for various reasons with regards to time-sensitive announcements.  <b>G2</b> = Lead Umpire retains Game Time Decision authority/responsibility in consultation with Head Coaches, based on rules/regulations/recommendations published by the Field Owner. Coaches &amp; Players shall plan to arrive as usual for the scheduled game time regardless of immediate weather and/or assumed field conditions.</p>
